2020 Business Booth Application

Rules & Regulations

- Festival hours are 9am to 4pm.**
- Participants are responsible for setting up and dismantling of their booth. Tents, tables, etc. are to be provided by participants.
- Registration and payment is required. We accept applications and credit card payments electronically through our website at www.GreatDayOviedo.org. To submit by mail:

- Make checks payable to: **GFWC Oviedo Woman's Club.**
- Booth fee is **\$300.00 plus tax** (\$275.00 for Oviedo Winter Springs Chamber of Commerce members.) Prices subject to change.
- No refunds after October 15, 2020.
- All partners sharing a booth must be listed on application.
- Once you have applied and your application has been accepted, you will receive a confirmation email within 60 days.
- There will be limited vendors in each like category.**
- Each booth space is approximately 10' x 10'. **We do not provide tents, tables, chairs, etc.** All work is to be contained within the assigned space.
- You will be provided a Booth Identification Card which **MUST** be prominently displayed on the front of the booth for the duration of the show.
- There is electricity available for a limited amount of booths for an additional cost of **\$25.00 plus tax**. The types and costs for booths are listed on Page 2.
- Once you have applied and your application has been accepted, you will receive a confirmation email within 60 days.
- Tents must be weighted or tied down to prevent blowing over. Any electrical or other cords running on the ground need to be secured with tape down their entire length or covered to prevent tripping hazards.
- Only one vehicle per booth is allowed on the field during set up on Friday and Saturday.** Unload merchandise and immediately move your vehicle to the parking area before beginning booth setup.
- NO PARKING IS PROVIDED ON GROUNDS.** There is **not** a reserved lot for vendors, however, **there will be reserved parking in the lot at Oviedo Blvd. and Center Lake Lane for a cost of \$25.00 per space. One space per vendor. Reservations must be made before the event. Assignments will be on a first come basis.**
- Information regarding booth setup, booth numbers, and gate entrances will be sent to accepted participants by late October.**
- Row M (City Plaza Way) cannot set up until Saturday morning.**
- You **cannot** start breaking down your space until 4:00 PM. Please break down and pack up **BEFORE** getting your vehicle. Cars are not allowed on the grounds and Food Trucks may not be removed until approximately 4:15 – 4:30 when the Oviedo Police gives the clearance. You must finish your cleanup and be off the grounds by 6:00 pm.
- No sales are permitted by Businesses.**
- NO food or drink sales are permitted in the booth.
- NO alcohol, drugs or unlawful transactions are permitted.
- If any violation occurs, the business will be asked to leave.
- Great Day in the Country is held rain or shine. There is no rain date.
- If weather conditions are extremely unfavorable the GFWC Oviedo Woman's Club may cancel all activities.
